# DETERMINATION OF TARIFFS AND CHARGES FOR CIVIL ENGINEERING RELATED SERVICES

### **PURPOSE OF REPORT:**

The purpose of this report is to amend the tariffs and charges for Civil Engineering related services.

### **BACKGROUND:**

A uniform set of tariffs and charges in respect of Civil Engineering related services was promulgated and implemented with effect from 1 October 2002.

These tariffs and charges must be amended annually and the schedule contained in the recommendation below, indicates proposed tariffs for the various services from 1 July 2013.

### **RECOMMENDATION:**

That in terms of the provisions of Section 74(1) of the Municipal Systems Act 32 of 2000, as amended, the following tariffs be determined with effect from 1 July 2011.
