**RECOMMENDATION:**

- a) That no telephonic reservations for the hiring of halls or any other facilities of Council be accepted and that reservations only be made on the official application form and a 50% hiring fees be paid with the reservation.
- b) That the escalation of fees for hiring of halls be revised by Council and to be implemented from 1 July 2015 to 30 June 2016, in terms of section 24 of the MFMA, 56 of 2003.
- c) That reservations of halls on a regular long term basis only be reserved for one month in advance.
- d) That cognizance taken that no tariff be approved for the old Hartbeesfontein Council Chamber and it only be used for Council events.
- e) That Council determine it as policy that no halls or facilities of the Council are made available free of charge for use by the public, associations, organisations and schools: Provided that 100% discount be allowed to schools hiring halls or facilities for examination purposes. All schools get 50% discount once a year.

- f) That no reservations for halls be accepted from the public before 1 September for the next year running from 1 July
- g) That the cashiers receiving the deposit on the rent of a hall, reminds the lessee to show his/her receipt to the reservation official.
- h) That if a hall/venue booking be cancelled within 48 hours of the event, the rental be forfeited.
- i) That all halls and facilities be vacated by their lessees at 17:00 for a day function and 24:00 for a night function respectively, failing of which, another day's tariff be charged.
- j) That no eating and drinking be allowed inside the Klerksdorp Auditorium.
- k) That NO halls will be available over Christmas as well as Easter weekend.
- l) That for the following, the halls shall be free of charge:-
  - i. Functions for municipal purposes
  - ii. Ward meetings by Ward Councillors (PA system excluded)
  - iii. Zephyrus Youth Wind Orchestra
  - iv. Municipal Unions
  - v. UIF for payment or handing out and collection of application forms (once a month)
  - vi. Council for conciliation, mediation and arbitration (CCMA)
  - vii. International Electro technical Commission (IEC)
  - viii. South African Police Services (SAPS) only meetings and workshops
  - ix. Funerals of Officials and Councillors
    - x. Dr Kenneth Kaunda District Municipality
    - xi. South African Local Government Association (SALGA)
    - xii. Municipal Employees Association/Association of Municipal Employees
  - xiii. Street festival
  - xiv. Air show
  - xv. Government of the day
- m) That all lessees (excluding uses "free of charge") pay R250.00 (VAT included), with the Booking fee, per function, for the Councils Caretaker when opening and closing of halls is required after hours, (Office hours - 6:30 until 15:30)
- n) That no tables and chairs be borrowed or used outside Council's halls, as resolved per Mayco resolution 769/2012.
- o) That South African Social Security Agency (SASSA) pay the normal hall tariffs as considered  
And resolved per Mayco resolution 522/2013.
- p) That an amount of R600.00 (VAT included) per hour be payable for diesel if the Council's Generator is started especially for the function taking place during load shedding applied by Eskom.
