1. **DEFINITIONS**

In these by-laws, except as otherwise expressly provided or unless the context otherwise requires –

"Approval" means approval by the authorised official and

"Approve" has a corresponding meaning:

"Authorized official" means an official of the Council authorized to implement the provisions of these by-laws and "officer" shall have a corresponding meaning;

"Council" means the City Council of Klerksdorp;

"Foodstuff" means foodstuff as defined in section 1 of the Foodstuff Cosmetics and Disinfectants Act, 1972 (Act No 54 of 1972);

"Garden or Park" means a garden or park to which the public has a right of access;

"Goods" includes a living thing or any transferable interest;

"Local Authority" means a local authority as defined in the Act;

"Litter" includes any container or other matter which has been discarded and abandoned or left behind by a person trading or his/her customers;

"Pavement" means sidewalk as defined in section 1 of the National Road Traffic Act of 1996 (Act 93 of 1996)

"National Monument" means a building or structure declared to be a National Monument under the National Monuments Act, 1969 (Act 28 of 1969);

"Prohibited Area" means any place declared or to be declared under section 6A (2) of the Act by resolution of the Council to be an area in which Street Trading is prohibited;

"Property" in relation to a person carrying on the business of Street Trading, means any article, receptacle, vehicle or structure used or intended to be used in connection with such business, and includes goods in which he / she trades;

"Public Building" means a building owned and / or occupied by the State of the Council;

"Public Place" means a public place as defined in Section 2 of the Local Government Act, 1939 (Act 17 of 1939)

"Public Road" means a public road as defined in section 1 of the National Road Traffic Act, 1996 (Act 93 of 1996);

"Services" includes any advantage or gain for consideration of remuneration or reward;

"Sell" includes supply to and also -

- (a) exchange, hire out or barter;
- (b) store, expose, offer or prepare for sale and "sale" has a corresponding meaning;
- (c) provide a service for reward

"Side Walk" means a side walk as defined in section 1 of the National Road Traffic Act, 1996 (Act 93 of 1996)

"The Act" means the Business Act, 1991 (Act 71 of 1991);

"Trade" means the lawful sale of goods or services in a public road or public place, and "trading" as well as "display to trade" has a corresponding meaning;

"Verge" means a verge as defined in section 1 of the National Road Traffic Act, 1996 (Act 93 of 1996), and any word or expression to which a meaning has been assigned in the Business Act, 1991 (Act 71 of 1991);

"Pedestrian crossing" means a pedestrian crossing as defined in the National Road Traffic Act, 1996 (Act 93 of 1996);

"Vendor" any person who sells:

"Hawker/Street Trader" means a person who carries on the business of hawking or street trading;

"Hawking/Street Trading" means the selling of any goods (including a living thing) or the supplying or offering to supply any goods or services for reward, a street vendor peddler, or hawker in a public road or place but does not include the sale of newspaper only;

"Vehicle" includes – (a) a self propelled vehicle

- (b) a trailer
- (c) a hand-drawn or propelled vehicle

For the purpose of these by-laws a single act of offering for sale or of selling goods or services in or from a public road or public place constitutes the carrying on of the business of a street trader;

For the purpose of these by-laws a reference to person carrying on the business of street trader shall include any employee of any such person;

2. RIGHT TO TRADE

- (a) Subject to the provisions of section 3 and 4 and any other law, street trading is permitted except in so far as such trading is restricted or prohibited by sections 5 and 13 inclusive
- (b) Hawkers shall have a right to trade upon payment of R 40 per month or part thereof for the stand leased to him/her or otherwise allocated to him / her by the local authority and shall be issued with a disc which shall be displayed by hawkers at all times.
- (c) Discs shall be issued against proof of South African Citizenship or proof of a valid work or residence permit.
- (d) No vehicle traders shall be allowed to park any vehicle on side walks or to make use of any parking-bay to conduct business thereon.
- (e) Lost discs shall be replaced against payment of the fee of R10
- (f) The validity of the right to trade shall be renewed and endorsed after every six months.

3. GENERAL CONDUCT

A person shall –

- (a) Not place his/her property on a verge or public except for the purpose of commencing to trade;
- (b) Ensure that his/her property does not cover an area exceeding a demarcated stand for hawking by the local authority;
- (c) Not conduct any business or display goods within two meters from the corner of a building measured from the building line adjacent to a crossing;

- (d) Not conduct any business or display goods within two meters from the entrance to a building, shop or premises, and no trading shall be allowed within 20 meters from any financial institution;
- (e) Not conduct any business or display goods within 20 meters measured from any corner of a shop conducting business with the same goods as the vendor is dealing with, unless he/she has written approval of the owner or lessee of that specific shop;
- (f) Not conduct any business or display goods on any other place except on a demarcated stand reserved for that specific purpose by the local authority;
- (g) Not place or stack his/her property in such a manner that it constitutes a danger to any person or property or is likely to injure any person or damage property / or obstruct movement of pedestrians;
- (h) Not obstruct access to a fire hydrant;
- (i) On concluding business for the day remove his/her property, except a structure permitted by the local authority to a place which is not part of a public road of public place;
- (j) Not display or sell his goods or other property on a building or other private property without the consent of the owner, occupier or person in control of such building or property;
- (k) On request by an employee or agent of the council or any supplier of telecommunication or electricity or other services, move his/her property so as to permit the carrying out of any work in relation to a public road, public place or any such service;
- (l) Not attach any object by any means to any building, structure, pavement, tree, parking meter, lamp post, electricity pole, telephone booth, post box, traffic sign, bench or any other street furniture in or on a public road or public place;
- (m) Not make a fire on any pavement, garden, park, side walk or public place;
- (n) Not store his/her property in a manhole, drainage pipe, drainage system, storm water pipe, bus shelter, public toilet or tree;

4. CLEANLINESS

A person trading shall -

- (a) Keep his/her property and the area or site occupied by him/her for the purpose of such business in a clean and sanitary condition;
- (b) Keep his/her property in a clean and sanitary condition;
- (c) Dispose of litter generated by his/her business in whatever receptacles provided by the local authority, including recycling and dumping sites, and not dispose of litter in a manhole, storm water drain, side walk or other place not intended for disposal of litter;
- (d) Ensure that on completion of business of the day the area or site occupied by him/her for the purpose of trade is free of litter;
- (e) Take such precautions as may be necessary to prevent the spilling onto a public road or public place of any fat, oil or grease in the course of conducting his/her business and to prevent any smoke, fumes, odours or noise emanating from his/her activities form becoming a nuisance;
- (f) The highest point of display shall not be higher than 500 mm from the ground floor in front of a shop window and where there is no shop window higher than two meters.

5. OBSTRUCTION OF PEDESTRIANS

No person shall trade at a place where such trading –

- (a) Obstructs access to or use of street furniture such as a bus passenger bench or shelter or queuing line, refuse disposal bin or other facility intended for the use of the general public;
- (b) Obstructs the visibility of a display window in business premises, if the person carrying on business in the premises concerned objects thereto;
- (c) Obstructs access to a building, automatic bank teller machine, pedestrian crossing or motor vehicle.

6. OBSTRUCTION OF VEHICULAR TRAFFIC

No person shall trade at a place where such trading –

- (a) Causes an obstruction on a roadway;
- (b) Limits access to parking or loading bays or other facilities for vehicular traffic;
- (c) Obscures any road traffic sign or any marking, notice or sign displayed or made in terms of these or any other laws; or
- (d) Interferes in any way with any vehicle or access to such vehicle that may be parked alongside such place;

7. TRADING RESTRICTED TO SPECIFIED HOURS IN CERTAIN PLACES

No person shall trade –

- (a) On a verge contiguous to any Place of Worship, National Monument or public building; or
- (b) In a restricted area, which is specified in Schedule A, compiled according to the consultation process outlined in Section 6A (2)(a) to (j) of the Act outside the hours so specified in relation to each such garden, park, verge or area.

8. TRADING RESTRICTED TO SPECIFIED GOODS OR SERVICES IN CERTAIN PLACES

No person shall trade -

- (a) on a verge contiguous to any Place of Worship, National Monument or public building; or
- (b) in a restricted area, which is specified in Schedule B, compiled according to the consultation process outlined in Section 6A (2)(a) to (j) of the Act, other than in the goods or services so specified in relation to each such garden, park, verge or area.

9. TRADING RESTRICTED TO DEMARCATED STANDS OR AREAS IN CERTAIN PLACES

No person shall trade -

- (a) On a verge contiguous to any Place of Worship, National Monument or public building;
- (b) In a restricted area, which is specified in Schedule C, compiled according to the consultation process outlined in Section 6A (2)(a) to (j) of the Act outside a stand or area set apart for trading purposes as contemplated in section 6A (3)(b) of the Act;
- (c) In or nearer than 20 meters from the bus houses in Church Street between Pretoria Street and Voortrekker Road; or
- (d) In all other areas except the following:

KLERKSDORP

- Northern boundary Road P3.5
- Eastern boundary Margaretha Prinsloo Street
- Western boundary Park Street between Trans Erasmus Road and Road P3.5 (Main Reef Road)
- Southern boundary Trens Erasmus Road

ORKNEY: within the following streets:

- Kingsley Street
- Shakespeare Street
- Milton Avenue
- Fletcher Street

STILFONTEIN: within the following streets:

- Hartbeesfontein Road
- Stilfontein Road
- Somerset Drive

10. NO TRADING IN STANDS OR AREAS WHICH HAVE BEEN LET EXCEPT BY THE LESSEE

If the Council has let or otherwise allocated any stand or area set apart or otherwise established for street trading purposes, as contemplated in Section 6A (3)(c) of the Act, no person may trade in such area if he/she is not in possession of proof that he/she has hired such stand or area from the Council or that it has otherwise been allocated to him/her.

11. NO TRADING NEAR CERTAIN PUBLIC BUILDINGS, PLACES OF WORSHIP AND NATIONAL MONUMENTS

No person shall trade on a verge contiguous to any place of Worship, National Monument of public building which is specified in Schedule D, compiled according to the consultation process outlined in Section 6A (2)(a) to (j) of the Act, unless he/she obtains written consent from the local authority, which consent shall not be unreasonably withheld.

12. NO TRADING IN PROHIBITED AREAS

No person shall trade in any prohibited area.

13. TRADING NEAR RESIDENTIAL BUILDINGS / HOUSES

No person shall, outside an area specified in Schedule E, compiled according to the consultation process outlined in Section 6A(2)(a) to (j) of the Act, trade in that half of a public road contiguous to a building used exclusively for residential purposes if –

- (a) The owner, person in control or occupier of any part of the building facing onto such road has objected thereto; and
- (b) the fact that such objection was made has been made known to the first mentioned person by an authorized official

14. SIGNS INDICATING RESTRICTIONS AND AREAS

The Local Authority may –

- (a) By resolution, after consultation with all interested parties, prescribe signs, marking or other devices approved by the Premier indicating:
 - (i) Specified hours, places, good or services in respect of which street trading is restricted;
 - (ii) The location or boundaries of a restricted area;
 - (iii) The boundaries of a stand or area set apart for the purpose of the carrying on of the business of street trading under Section 6A(3)(b) of the Act;
 - (iv) The fact that any such stand or area has been let or otherwise allocated;
 - (v) Any restrictions or prohibition against trading in terms of these laws; and
 - (vi) The location of boundaries of a prohibited area; and
- (b) display any such sign, marking or device in such a position and manner that will indicate the restrictions or the location or boundaries of the area stand concerned

15. REMOVAL AND IMPOUNDMENT

- (1) An officer may remove and impound any goods, article, receptacle, vehicle or structure
 - (a) Which he/she reasonably suspects is being used or intended to be used or has been used in or in connection with street trading; outside the provisions and meaning of these by-laws; and
 - (b) Which he/she finds at a place where street trading is restricted, prohibited in terms of Section 5 to 13 inclusive and which, in his/her opinion, constitutes an infringement of any such section; and
 - (c) As referred to in section 3 (d) hereof.
- (2) The disposal of any goods, article, receptacle, vehicle or structure removed and impounded as contemplated in subsection (1), and the liability of a person for the expenses incurred in connection with such removal, impoundment and disposal, shall be recovered in accordance with regulations prescribed by the Premier under Section 6(1)(b) of the Act.

16. OFFENCES

Any person who contravenes a prohibition or limitation in these By-laws or fails to comply thereto shall be guilty of an offence and shall upon conviction be punishable with a fine as determined in section 17 of these by-laws.

17. PENALTIES

Any person who is guilty of an offence in terms of these by-laws shall upon conviction be liable to a fine or to imprisonment as determined from time to time by the local magistrate.

18. VICARIOUS RESPONSIBILITY OF PERSONS CARRYING ON BUSINESS

When an employee of a person conducting the business of street trading does or omits to do any act which would be an offence in terms of these by-laws for a person to do or omit to do, that person shall be deemed, himself/herself to have done or omitted to do the act, unless he/she satisfies the court that —

- (a) He/she neither connived at nor permitted the act or omission by the employee concerned;
- (b) He/she took all reasonable steps to prevent the act or omission; and
- (c) An act or omission, whether lawful or unlawful, of the nature charged on no condition or under no circumstance fell within the scope of the authority or employment of the employee concerned, and the fact that the said person issued instructions whereby an act or omission of that nature in prohibited shall not in itself be sufficient proof that he/she took all reasonable steps to prevent the act or omission.

19. VICARIOUS RESPONSIBILITY OF EMPLOYEES

When a person carrying on the business of street trading is by virtue of Section 18 liable for an act or omission by an employee of that person, that employee shall also be liable as if he/she were the person carrying on the business concerned.

20. PRESUMPTIONS

- (1) In any prosecution for an offence under these by-laws, an allegation in the charge concerned that –
- (a) Any goods with which a business was carried on were not a particular kind, class, type of description;

- (b) Any goods were sold or offered for sale;
- (c) Any place was situated in a public road or public place or within a particular area;
- (d) Any person carrying the business of street trading and in a manner and place alleged;

Shall be presumed to be correct unless the contrary is proved.

- (2) In any criminal proceedings for a contravention of these by-laws, where it is shown that
 - (a) Any goods were displayed in a public road or public place, such goods shall be presumed to have been offered for sale;
 - (b) Any property used in the provision of any service was available in a public road or public place, such services shall be deemed to have been offered for supply.

21. REPEAL BY-LAWS

Any by-laws which were previously applicable and related to licensing and business control in relation to informal trading, is hereby repealed.

- c) That LED Division conduct training for hawkers on the following topics: Cleanliness; how to set up a business; marketing and sales; as well as financial management.
- d) That LED Division engage the Hawkers Associations on the schedule and training dates.
- e) That LED Division considers all service providers in conducting the training.
- f) That LED Division engage the private sector and mining houses and other government departments in funding these training.
- g) That Council takes cognisance of the response to informal traders.
- h) That Public Safety Department enforces the law consistently and continuously, including removal of cars from the pavement parked by the car dealers.

INFORMAL TRADING POLICY

STREET TRADING SITE AND IDENTITY CARD

- No person may conduct the business of a street trader in the business area without being in possession of a valid street trading identity card issued by the Council (Public Safety Department).
- A person who wants to do street trading in the business area, must apply to the Council on a prescribed form for the allocation of a street trading site to him where possible.
- On allocation of such a site to the application, street trading identity card will be issued to him, after payments of the prescribed fees, if any.
- Such street trading identity card issued by the Council must on demand be provided to an officer or an employee of the municipality.
- The Council may reduce, extend and or disestablish any street trading site. At least 30 days written notice will be given to a street trader to vacate a site that will be disestablish.

CANCELLATION OF STREET TRADING IDENTITY CARD

- 1 The Council may withdraw and cancel a street trading identity card if:
 - a) A street trader fails to pay any prescribed fees as determined in the by-laws of the Municipality for a period of 60 days, and
 - b) A street trader is found guilty of a contravention of any of these by-laws.

STREET TRADING STRUCTURES

- The Council may erect structures on street trading sites in the business area, which structures shall be leased on a monthly basis to the street trader to whom the site have been allocated.
- A street trader shall on demand, produce a proof of payment of the lease for the structure to an officer or an employee of the Municipality.

EXEMPTION

The municipality may exempt any person, organization, group or committee from obtaining a street trading identity card for specific event or function and for a specific period. Such exemption must be in writing, and must on demand be provided to an officer or employee of the municipality.

PROHIBITED GOODS

The following goods may not be sold by the street traders in the business area.

- a) Live-stock, pets, reptiles, birds, rabbits wild animals and, or poultry except with prior written approval of the council.
- b) Raw meat or raw fish.
- c) Milk
- d) Any form of alcohol or alcoholics drinks.
- e) Vehicle. Trailer, Caravans.
- f) Any noxious or smelly substance or articles that may cause a nuisance.
- g) Pesticide, insecticide, poisonous and, or hazardours substances.
- h) Any counterfeit goods or articles and any goods prohibited by legislation.
- i) Hairdressing salon.

PROHIBITED AREAS

- Street trading in the business area may only be conducted from a street trading site allocated by the Council and it is prohibited to sell from any site.
 - a) In any garden or park which is zoned as a public or private open space and to which the public has a right of access.
 - b) On a sidewalk adjacent to:
 - a. In building belong to our occupied solely by the Council or an organ of state.
 - b. A church or other place or worship.
 - c. A building declared to be a national heritage resource in terms of the National Heritage Resources Act, 1999 (Act No.25 1999)
 - d. An automated teller machine.
 - c) At a place where
 - i) It causes or may cause an obstruction in front of a fire hydrant or an entrance to or exit from building.
 - ii) It causes an obstruction to vehicle traffic.
 - iii) It substantially obstructs or may obstruct pedestrians or persons in wheelchairs or other disabled persons in their use access to a sidewalk.
 - d) On sidewalk adjacent to a building which business is being carried on by any person who sells goods of the same nature as or of a similar nature to goods being sold by the street trade concerned, without the consent of that person.
 - e) On that half of a public road adjacent to a building used for residential purposes, if the owner or person in control or any occupier of the building objects thereto.
 - f) Within 5 (Five) meters of any signalized interaction of two or more streets, measured from the nearest end of the curve in the kerb line, with no part of any structure nearer than 2 (two) meters from the edge of the road and not within 20 (twenty) meters from any priority controlled (unsignalised) intersection of two or more streets, measured from the nearest end of the curve in the kerb line and with no part of any structure nearer than 2 (two) meters from the edge of the road.

- or .
- g) At any place where the selling of goods limits or may limit access to parking or loading bays or any other facilities for vehicular traffic.
- h) Within the reserve of any road.

STREET TRADING IN RURAL AREAS

Street trading is allowed within the rural area, subject to provision of the by-laws and other applicable legislation.

MISCELLANEOUS

Control Measures

- 1 Street trader shall not
 - Sleep overnight at his place of selling.
 - Erect any structure at his place of selling, except a device or structure for which written approval has been obtained from Council on the prescribed form.
 - Carry on his business in such a manner as to :
 - Create a nuisance
 - Damage or deface the surface of any public road or public place or any other property of the Council.
 - Create a traffic hazard
 - Litter, accumulate, dump, store or deposit or cause or permit to be accumulated, dumped, stored or deposited any refuse, scrap or waste material on any land or premises or on any public road or public place or waterway, other than in a refuse receptacle approved by the Council.
 - Burn any goods, materials or refuse or start a fire for any reason other than preparing food stuffs for which the street trader has the necessary approval.
 - Permit or cause any goods, receptacles or refuse to be placed outside the demarcated confines of the approved street trading stand.
 - Selling his / her goods or services in or at a building or property without the consent of the owner, lawful occupier or person in control of such building or property.
 - Take up position or place his / her goods or property on a place in contravention of a notice or sign erected or displayed by the Council for purposes of the by-laws.
- 2 A street trader shall
 - Remove everyday from any public road or public place at the conclusion of selling, waste, packaging material, stock and equipment of whatever nature which are utilized in connection with such business, unless prior written approval exempting him from this provision, has been given by the Council.

 At the instruction of an officer or an employer of the Council, move or remove any goods, receptable, vehicle or structure used for his business, or any litter and refuse on or adjacent to his stand.

REMOVAL AND IMPOUNDMENT

- An officer may remove and impound any goods, receptacle, vehicle or structure which he reasonably suspects are being used or are intended to be used or have been used in or in connection with street trading.
 - a) Which are prohibited goods.

b) Which he finds at a place where street trading is prohibited.

- Which a street trader has failed or refused to remove from the place after having been instructed to do so by an offer or an employee of the Council, or which have been left there or abandoned.
- 2 An officer acting in terms of subsection (1)
 - a) Shall issue to a street trader a written proof of impoundment for any goods, receptacle, vehicle or structure so removed and impounded: Provided that the officer may attaché the written proof to an approved structure if no person is available to receive the written proof and where no structure is available the written proof of impoundment shall be kept in the Municipality's records.
 - b) Shall forthwith deliver any such goods, receptacle, vehicle or structure to the Council.
 - May, and shall on instruction of an Environmental Health officer destroy all perishable and prohibited goods after 24 hours after impounding the said goods.
- Goods, excluding prohibited goods, receptacles, vehicles or structures can be returned to a street trader after payment of the determined fines and proscribed fees levied for impounding and storing, except if a magistrate make another ruling in this regard.
- The Council may discard with, sell or give away any goods, receptacles, vehicles o structures that have not been collected from the Council in terms of subsection (3), within 14 days after the date of impoundment.
- An offer, the Council or an employee of the Council shall not be liable for any loss or their of or damage to any goods, receptacle, vehicle or structure removed an impounded and or destroyed in terms of these by laws.

OFFENCES AND PENALTIES

A person who:

- b) Threats, resists, interferes with or obstructs any officer or any employee of the Council in the performance of his duties functions in terms of the Council these by laws, or
- c) Deliberately furnishes false or misleading information to an offer or an employee of the Council.
- d) Fails to comply with an instruction from an office to move or remove his or her goods, receptacles structures, liter.
- e) Fails to comply with any condition granted or imposed in terms of these by laws.
- f) Ignores disregards or disobey any notice, sign or marking displayed or erected.

PENALTIES

Any person who is guilty of an offence in terms of these policy shall upon conviction be liable to a fine or to imprisonment as determined from time to time by the local magistrate.

POLICY PROVISION (S) REGULATIONS

- The provision of City Council of Klerksdorp, notice No. 396 of 1997 : street trading by laws shall be upheld at all times.
- o The general conduct as stipulated in the city's by laws shall be adhered to at all times.
- Hygiene standards, and cleanliness shall be adhered to as stipulated in the city's by-laws and health regulations.
- Traffic and safety rules shall be observed and upheld at all time when trading / vending / hawking.
- Various responsibility of persons carrying on business as stipulated by the city's by-laws on street trading shall be observed at all times.

Failure to comply with policy regulation on street hawkers / traders as well as the City Council of Klerksdorp: Street trading by laws. Notice 396 of 1997 shall constitute an offence and shall upon conviction be punishable with a fine or a maximum penalty as prescribed by Section 17 of City's Street trading by Laws.

STAKEHOLDERS FORUM FOR STREET VENDING HAWKING

There shall be a street trading stakeholders forum which amongst other things shall be responsible for.

- a) Advising the Council and street traders on matters of street trading.
- b) Ensuring that there is an understanding between Council and hawkers / street traders.
- c) Maintenance of communication between all the stakeholders.
- d) Any other street trading issue referred to it by the municipality or street hawkers / vendors / traders.

PERMANENT HAWKING SPACE TO HAWKERS IN THE MATLOSANA AREA KLERKSDORP

- a) That the following areas have been identified to be developed into a permanent hawking place.
 - Southern part of Voortrekker street, between Emily Hobhouse and OR Tambo street.
 - 2 Parking area between Pagel Backer bridge and the terminus centre.
 - 3 Temporary vending stands as allocated by Council.
 - 4 Corner Wessels / Leemhuis Streets.
 - 5 Jazz Bar Taxi Rank
 - 6 John Orr Street next to Klerksdorp Hospital
 - 7 Corner Ian Street and Chris Hani Street
 - 8 Corner Austin and Yusuf Dadoo Street
 - 9 Corner OR Tambo Extension and Vaal Maseru Crossing (Leemhuis) Street
 - 10 Corner Terblanche and Greyhond street
 - 11 Tom Street between Williams Street and the buffer Crossing (Wilkopies)
 - Williams street behind Pick n Pay and the buffer Crossing.
- b) That stands mentioned in (a) above be re-designed into bigger stands and be sheltered.
- c) That stands be allocated at the Terminus Taxi Rank and be sheltered.
- d) That Enoch Sontonga and Emily Hobhouse streets only be considered for future housing of hawkers should the need arise.
- e) That the parking space next to Malibu Centre not be considered at all for hawking.
- f) Caravans must also be considered when allocating hawking sites at the Terminus Taxi Rank.
- g) Caravans doing business at the Taxi Rank must only be allowed to do so from 06h00 to 18h00 and must be removed after business hours.
- h) That all hawkers from different organizations be encouraged to register so as to be in a position to know exactly how many hawkers to cater for.
- i) That the selling of items like liquor by hawkers must be prohibited at all costs.

- j) That hawking at illegal places must be discouraged.
- k) That the Department: Civil Engineering be requested to do an investigation concerning the condition of toilet facilities at all hawking areas and a report be submitted to Council for further consideration.
- i) That shop owner is not allowed to grant permission to any hawker / trader to do business in front of his / her business.
