In terms of Sections 35 (1) of the Spatial Planning and Land Use Management Act, 16 of 2013, the City of Matlosana Local Municipality hereby invites nominations for members of the public to be appointed to the City of Matlosana Municipal Planning Tribunal for its first term of office.

The period of office of members will be five (5) years calculated from the date of appointment such members by the City of Matlosana Municipal Council.

- (b) The name, address and identity number of the nominee;
- (c) Motivation by the nominator for the appointment of the nominee to the City of Matlosana Municipal Planning Tribunal (not exceeding one (1) page);
- (d) A short Curriculum Vitae of the nominee (not exceeding two (2) pages);
